

Terms of Service

This site and terms of service is offered to you conditioned on your acceptance without modification of the terms, conditions and notices contained herein. Your use of this site constitutes your agreement to all such terms, conditions, and notices. This site is powered and operated by Power Mojo, LLC ("Power Mojo", "we" or "us"). You must be 18 years of age or older to use this site. You may browse parts of our website without creating an account, however, if you would like to use Power Mojo's Service, you will need to subscribe as a Member.

Power Mojo is a service of Power Mojo, LLC, that, among other things, allows Members to locate, evaluate, and enroll in energy services through third party providers. Power Mojo is a membership service which provides its members ("Members") our technology-based concierge energy shopping, carbon management advice and comprehensive customer portal, more information is described below under Retail Electric Providers and Our Services. By using the Service, you accept the terms of this Agreement, Agency Authorization and Privacy Policy. Power Mojo reserves the right to modify these terms and may provide notice of any changes as described below. The Service is only available to Members to assist in the purchase of energy. Additionally, optional related services may be purchased. The price and other terms remain subject to service agreements between the buying Member and the third-party provider. Power Mojo cannot guarantee the rates and/or services provided by the third-party vendor. Enrollments and contracts with energy providers are between the energy provider and the Member. Power Mojo is not a party to such contracts and shall have no liability or responsibility to you or the energy provider, including with respect to any disputes arising out of the contract between the Member and the energy provider, such as disputes related to the parties have fully performed their obligations thereunder or whether a contract has been validly entered into or concluded.

Power Mojo has the right to cancel or suspend a Member's account at any time and without notice upon a breach, violation or non-compliance of this Agreement or any other policies, terms of use, or agreements of Power Mojo. Notwithstanding the foregoing, under no circumstances shall Power Mojo be required to issue refunds hereunder.

Membership

The use of the Power Mojo site requires a Power Mojo Membership subscription. We currently offer two options: Monthly and Annual subscriptions. A subscription fee is assessed for each meter (premise).

- Our monthly subscription will equal monthly recurring payments, charged upon enrollment. Your subscription will automatically renew on the specific date you enrolled for our services, at the same fee amount, unless we notify you of a fee change 30 days in advance.
- Our annual subscription with a single annual payment for one year, charged upon enrollment.

Power Mojo reserves the right to increase fees with 30 days advance notice to the Member, except the annual fee which remain the same until the annual renewal date unless we notify you of a fee increase 30 days prior to your annual renewal date.

Your membership will automatically renew on a monthly or yearly basis based on your billing preference until you cancel your membership without penalty by contacting us at <u>mymojo@PowerMojo.com</u> or by phone (832) 632-8360 during normal business hours.

Monthly Power Mojo subscriptions may not be transferred to another meter or Member.

Although we strive to make the Power Mojo service available as much as possible, there may be periods of downtime (such as scheduled maintenance, software updates, or events outside of our reasonable control).

Multi-Premise Discount

In some cases, we may offer a discounted Power Mojo Membership subscription when you have more than one meter on the same account. You may contact customer service at mymojo@PowerMojo.com for more



information. Power Mojo reserves the right, in its sole discretion with or without prior notice, to do any one or more of the following: (i) limit the available quantity of or discontinue the service or any product or service; (ii) impose conditions on the honoring of any coupon, coupon code, promotional code, or other similar promotions; or (iii) refuse to provide any user with any product or service.

Some restrictions may apply to the multi-premise discount.

Payment Terms

When you provide Power Mojo your credit/debit card information, you represent that you are the authorized user of the card and authorize Power Mojo to charge you the applicable annual fee or the monthly fee up front. You agree to notify us of any changes to the relevant account number, expiration date, CVV and billing address, or if the card expires or is canceled. You agree that we may receive updated credit card information (such as a new expiration date) from your card issuer.

We will charge your monthly recurring fee to the credit/debit card on file on each billing date for your Power Mojo Member subscription. You are responsible for reviewing your credit/debit card statement for billing accuracy.

Unless notified by Power Mojo, your subscription will automatically renew on your specific date based on when your signed up for our Member at the same fee, and you authorize us to automatically charge the subscription fee to your credit/debit card each billing date until you cancel your subscription 30 days prior to the auto-renewal by contacting Power Mojo at mymojo@PowerMojo.com. Subscription fees paid prior to cancellation are nonrefundable or pro-rated.

By subscribing to the Power Mojo service, you authorize us to charge the applicable subscription fees (and any other applicable fees, such as late fees) to the card on file.

If your credit/debit card reaches its expiration date and you have not updated your payment information with us or cancelled your Membership, you authorize us to continue billing your card and you will remain responsible for any uncollected amounts.

Each charge on the applicable billing date applies to the subscription period immediately following the billing date

All prices on PowerMojo.com are listed in U.S. Dollars.

We reserve the right to increase the monthly subscription fee for Power Mojo subscribers paying month-tomonth with no commitment, but we will notify you 30 days in advance. If you do not accept the new fees, you should terminate your subscription before the new fees go into effect.

We reserve the right to suspend or terminate your subscription to the service without notice if your credit card is rejected or if your card issuer seeks the return of payments previously made to us. You agree to pay (i) any outstanding balance in full within 30 days of cancellation of your subscription, and (ii) a late charge on all amounts more than 30 days past due. The late charge will be 1.5% of the past due amount or the highest rate allowed by law (whichever is less) per month. Dispute Resolution – Arbitration; Class Action Waiver

THE PARTIES HERETO HEREBY AGREE TO RESOLVE ANY DISPUTE, CLAIM, CONTROVERSY, LAWSUIT OR LITIGATION RELATING TO, OR ARISING FROM, THE USE OF THE SERVICES, OR IN CONNECTION WITH THE SERVICES, THROUGH BINDING ARBITRATION IN ACCORDANCE WITH THE PROCEDURAL RULES FOR COMMERCIAL DISPUTES OF THE AMERICAN ARBITRATION ASSOCIATION ("AAA"). THE SITE OF SUCH ARBITRATION SHALL BE HOUSTON, TEXAS. THE NUMBER OF ARBITRATORS SHALL BE THREE (3). EACH PARTY SHALL APPOINT ONE ARBITRATOR AND THE TWO ARBITRATORS APPOINTED BY THE PARTIES SHALL APPOINT THE THIRD ONE. IF THE ARBITRATORS CANNOT AGREE ON WHICH ARBITRATOR TO APPOINT, THEN THE THIRD ONE SHALL BE APPOINTED BY AAA. THE ARBITRATORS SHALL APPLY TEXAS LAW. THE ARBITRATION OF DISPUTES DESCRIBED IN THIS PARAGRAPH SHALL BE IN YOUR INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR(S) MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. CLASS ARBITRATIONS AND CLASS ACTIONS ARE NOT PERMITTED AND EACH PARTY HERETO HEREBY KNOWINGLY, VOLUNTARILY, AND INTENTIONALLY WAIVES THE RIGHT TO PARTICIPATE IN A CLASS ACTION OR CLASS ARBITRATION.

If you do not have an online energy provider account or have selected a new energy provider and plan identified by Power Mojo, you give Power Mojo permission to establish a new account on your behalf with the energy provider using the information you have provided to us. You agree to notify us immediately at <u>mymojo@PowerMojo.com</u> if you change your log-in information or if there are any other changing to your account information. Additionally, you authorize Power Mojo in a manner consistent with our **Privacy Policy** to contact your current retail electric provider and receive information about the status of your account, your energy usage, and your contact term end dates and eligibility to switch to a different energy provider.

Member understands and agrees that, depending on the level of service you select, by subscribing to the services, you are authorizing Power Mojo to initiate price searches, fetch pricing information, set up account access with energy providers, request and access energy usage and profile information, enroll in or cancel energy provider contracts, as well as authorizing us to perform other activities in connection with providing the services and to provide related or other services and products as may be offered by Power Mojo from time to time.

Power Mojo Members agree to abide by all terms and conditions of account access detailed in each third party's TOS or terms of service that has been set up using Power Mojo, including their energy provider's terms of service, TDSP and SMT. In addition, Members acknowledge and agree to adhere to all agreements and terms of service with energy providers, utilities or TDUs and other service providers including payment of invoices for using their products and/or services.

We reserve the right to retain data collected on behalf of the Member during the service. Upon termination of services, we will cancel any agreements made on behalf of the customer or transfer their access to the customer, unless expressly agreed to by the customer, within a reasonable period, up to 45 days. We are not responsible for delays by third parties in cancelling or transferring agreements. We may continue to receive data for terminated or transferred agreements and reserve the right to retain the data collected. We will not instigate new agreements after the termination of service.

If the member is moving into a new location or moving out of current location where we are providing services, the member will need to contact Power Mojo at <u>mymojo@PowerMojo.com</u> or by phone so that we may update our records as well as the energy provider of the date the customer is moving out of the location to terminate the energy services and connect services at their new location. This is the responsibility of the member to keep Power Mojo informed of these changes.

If the member has requested to set up auto pay with the energy provider it is the responsibility of the member to update Power Mojo of any changes to the card such as replacement of card, expiration date and billing address to the card so that Power Mojo may update our records and the records of the energy provider for their energy bill.

Each Member agrees and understands that he or she is appointing Power Mojo as his or her limited agent for purposes of selecting and enrolling the member's service location for electricity service with Retail Electricity providers from time to time on their behalf.
